This Addendum shall supplement, amend and become a part of the Contract Documents (Specifications and Drawings). All bids and construction contracts shall be based upon the modifications or items of clarification contained herein. Acknowledge receipt of this Addendum on the form of proposal. Failure to do so may subject bidder to disqualification.

## SPECIFICATIONS:

ITEM NO. 1: Please confirm that during summer break when this project is scheduled to be performed that no summer school or occupied campus concerns will exist.

**Response:** Facility will be unoccupied for summer break. Staff will be returning beginning August 1,

2017.

ITEM NO. 2: Specs state contractors are responsible for hazardous materials. Please

confirm that hazardous waste inspections, report, and removal/abatement are not to be included in the contractors bid and that the District will incur those costs

should they determine it necessary.

Response: No removal of hazardous materials is anticipated, and proposal should not include any

costs. In the event that any suspicious materials are encountered during construction,

immediately notify the District.

ITEM NO. 3: Specs say we are to include material testing. In the past the District has provided

those services. Please confirm material testing is to be included in contractors

bid.

**Response:** Material testing should be included in the contractors bid.

ITEM NO. 4: Plans show walls to be extended to bottom of roof deck. During pre bid meeting

District staff acknowledged that we do not have any conditions where that is necessary and that we can have the walls abut the bottom of ceiling grid. Please confirm this is correct. Also confirm detail 05 on sheet A251 for P2 wall is not

applicable to this project.

**Response:** Due to the sensitive nature of business conducted in Room 220, the new dividing wall is

to be Type P2, extended to deck above with sound insulation. All other new walls may

abut the bottom of the suspended ceiling.

ITEM NO. 5: Door 205 is called out to be a 3070 door on the schedule, but the jamb detail

shows it as a half high door. Please confirm which is correct.

**Response:** Door 205 is to be spring-hinged 3'-0"x3'-0".

ITEM NO. 6: On sheet A221 detail 07 shows a cabinet with plastic laminate top. Please

confirm the only plastic laminate tops are those existing that are to be relocated

and that all new tops will be solid surface.

**Response:** Confirmed. All new countertops are to be solid surface.

ITEM NO. 7: Plans do not show the cabinetry that needs to be removed in

Conference Room 215.

**Response:** Existing casework along north wall of existing Conference Room 220 is to be removed

per attached SK-D1. Patch floor tile where cabinets are removed to provide a seamless

appearance.

ITEM NO. 8: Please provide tile and grout selection specifications, i.e. manufacturer,

model number, color, etc.

Response: Daltile MA90 20"x20"
