

**Approval to Award RFQ #02-0-2017/JC to Multiple Firms for Mechanical Engineering Services - Mr. Morrison**

The Facilities, Planning and Construction Department requested that a Request for Qualifications (RFQ) be promulgated for professional mechanical engineering services. The purpose of this Request for Qualifications (RFQ) is to select a minimum of three firms to provide services for HVAC, Electrical and Plumbing (MEP) district wide on an as-needed basis pursuant to School Board Policy 6330, The Florida Consultant's Competitive Negotiation Act (CCNA) F.S. 287-055, Florida Statutes Chapter 1013 and Florida Administrative Code Rule 6A-2.0010. The annual financial impact as estimated by our Facilities and Planning Department is \$250,000. The Facilities Department will assign projects to the awarded firms on a rotating or best fit selection. The contract period of this RFQ is January 25, 2017 through January 24, 2018 and may, by mutual agreement between the Board and the awardees be renewable for two additional one year periods. It is recommended that this RFQ be awarded to TLC Engineering for Architecture, Inc., Johnson, Levinson, Ragan, Davila, Inc., SGM Engineering, Inc., BRPH, OCI Associates, Inc. and Graef-USA Inc. The Facilities, Planning and Construction Department requested that a Request for Qualifications (RFQ) for professional mechanical engineering services. The purpose of this RFQ is to select a minimum of three firms to provide engineering services for HVAC, Electrical and Plumbing (MEP) district wide on an as-needed basis pursuant to School Board Policy 6330, The Florida Consultant's Competitive Negotiation Act (CCNA) F.S. 287-055, Florida Statutes Chapter 1013 and Florida Administrative Code Rule 6A-2.0010. The estimated annual financial impact is \$250,000. The Facilities Department will assign projects to the awarded firms on a rotating or best fit selection. The contract period of this RFQ is January 25, 2017 through January 24, 2018 and may, by mutual agreement between the Board and the awardees be renewable for two additional one year periods.

Advertisement soliciting professional qualifications and Letters of Interest from qualified firms was placed in the Indian River Press Journal on September 15, 2016. Notices were mailed to eight (8) firms in our vendor data base and posted on Onvia DemandStar and the Purchasing Department's website. The Evaluation Team reviewed all responses and assigned points and are recommending the top six (6) firms as follows:
