Request for Funds:

Mrs. Debenedet spoke in front of SAC, presented the idea of having two-way classroom radios available for the teachers due to the recent, tragic events in Broward County at the February meeting. Several schools already have this safety initiative in place already. She presented the updated information for the two-way radios and SAC discussed it. The total price for classroom radios for the entire school is \$5,449.45.

Mrs. Carroll voted to approve the request for two-way radios. Mrs. Shaler seconded. All votes to approve the request were unanimous.

Stacey Miller presented the idea to repurpose the Rice Krispy treats that were originally used as cafeteria rewards as testing snacks. Any amount used to date for cafeteria snacks have been funded with private funds. From this moment forwards, the \$210 would be spent on after testing snacks (ex. Rice Krispy snacks).
