- B. Ben Folger made the motion to approve and Amanda Murdock seconded the motion provided the following changes were made:

- A. SAC Budget
  - 1. SAC Budget

      - (1) Created based on state money \$ per student provided

- (3) Teachers invited for presentation to SAC to request funds -for grant programs, ideas, resources, etc.
- 2. Two teachers were denied an Education Foundation grant keep in mind that we can open this up to them
  - (1) Budget this year not out yet, however, SAC finished last year with \$2-3K
  - (2) SAC will vote Schools "A" money this year goes to just teacher, staff, bus, etc... Teachers/Staff vote then we deny or approve
    - (a) (Dept Ed gives \$)
    - (b) Typically include whole school for 2018-2019 school year employees transfers will be included likely, resignations not typically included
- 3. Discussion on teacher presentation and examples given on how this functioned
  - a) SAC would provide deadlines and also determine amounts if any
- 4. Kindergarten was to have books funded last year Kristi Challenor said per Ms. Bishop the books were not funded. motion was originally passed, but did not follow through Need to research this issue
- B. SAC Bylaws
  - 1. SAC Bylaws Lorri opened discussion
    - (1) Extremely out of date
    - (2) BES online last updated 2009
    - (3) Students not allowed on SAC for elementary any more
    - (4) Cover how parents were elected this year in updated bylaw current bylaws did not apply to how election went
    - (5) Ben Folger stated he would take a look at a first draft
      - (a) Handed handwritten copy of bylaws by Principal Finnegan will scan in electronically
    - (6) Jenny Zeran said she would work with Ben Folger if needed
    - (7) Need to revisit each year
      - (a) District changes appear in June each year
- C. Safety Update
  - 1. Only school board employees on Safety Team
    - (1) -Safety team school head custodian, physical

- (a) Darius Vickers (Computer Lab Manager), Bob Boone (Head Custodian), Kelly Dixon (Physical Plant Manager), Susan Del Tufo (Assistant Principal), Rachel Finnegan (Principal), Bethany Rice (Administrative Assistant), Jennifer Gabbard (Literacy Coach), and Officer Charles McFarland (SRO) \*Behavior Intervention Specialist, Clarence Cooper, was just hired the week of October 7<sup>th</sup> and he will attend upon availability
- (2) FL all schools must have active fire drill and active assailant once a month
- (3) After action review what went well, what didn't, changes to make
- (4) If teachers not complying record, investigate
  - (a) Check compliance could be mechanical issues, a lot of issues we have had were mechanical/hardware
- (5) Power points prepared for children regarding both drills
- (6) Gate and fencing to be moved up K1 walk-up there has been a tense situation with kids running out
- (7) Ideally One door 5 children out at a time
  - (a) K-1 two teachers
- (8) Nick Westinburger and John Tesky updated not moving the fencing. Look at BES as a single point of entry. Front office and media center looking at plans to bridge together and see how to make single point entry. We are one of the 1st schools looked at due to poor visibility.
- (9) FSSAT 457 questionnaire perimeter fencing, entrances, camera views, dismissal, egresses, maps, pictures Completed by Princípal Finnegan
- (10) State is looking at all schools to promote safety and safer campuses.
- (11) Asking for paneling to cover pieces where small hand can fit around gates and fencing.
- (12) Osceola, Liberty, Glendale all canceling K1 walkup.
- (13) Some schools have stopped K1 walking to classes this may come as a district decision.
- (14) Discussed traffic concerns
