- First order of business vote SAC Chairman... Meredith Tatro
- Vote SAC Secretary Sylvia Marley

"A" School:

- Mr. Racine brought us up to date on the tremendous accomplishment of our student last year.
- Mr. Racine broke down the numbers as to how the "A" school is accomplished. He focused on how we could move all students forward to continue the great gains we have made.
- He spotlighted several students who gained honors through their accomplishment in various contests both county and state wide. Some of those outstanding students are still here as 8th graders.
- We are still a Silver School (PBS) but we are going for Gold this year. We are close.
- New this year, ALL students must wear a school PE uniform. Dr. Shaw wrote a grant for 81 uniforms for student with financial need.

Next order of business: The "A" school money.

- The award must be within the guidelines provided by the state.
- A copy of the three previous ballots was reviewed.
- A motion was made to accept these same ballots. Alan Keizer ... motion, Sylvia Marley...2nd
 Motion Passed.
- Approval of votes must be sent to School Board by October 31, 2010.
- Motion to approve ballot contingents upon result. Bud... Motion, Katy ... 2nd Motion Passed.
- Motion to approve a ballot to vote same as last year or start over was approved contingent on the desire of the A school money committee electing to create and use such ballot.

Next order of business: Request for funds.

- Approximately \$5000 was left in our account from last year.
- Motion was made to set aside the money for next year (2011) Cowboy camp. 5 teachers, 2 days
 plus 1 coordinator, @ \$1600 Bud ... motion to accept, Alan... 2nd Motion passed

Next order of business: Course recovery Teacher.

- There is no funding for after school buses or teachers this year.
- QSP Fund raiser money will go to afterschool buses.

- Buses will start October 5, 2010. They will run for @ 45 days or until FCAT at a cost of @ \$6000. At least 84 students now need course recovery.
- Need \$1400 for teacher, 1 ½ hour a day, Tuesday and Thursday... Start in October. Bud...
 Motion to approve, Alan... 2nd Motion passed

Next order of business: After school detention and activities.

- Detention Monitor: \$900
- Co ordinate clubs and such with after school buses Tuesday and Thursday, Two buses at a cost of \$135 a day. Bud..motion, Katy..2nd, Motion passed.

NOTE: All moneys approved include payroll taxes.

Discussion of remaining funds: If things go well we should still be able to have Cowboy camp in 2012. There will be NO Summer School Next Summer; there is no money for it.
