

### **SECTION OVERVIEW**

The School District will continue to operate under the requirements of the 1967 order (which requirements were not changed by the 1994 order) with respect to transportation which mandates that (1) no student shall be segregated or discriminated against on account of race or color in any service, activity, or program, including transportation, and that (2) where transportation is generally provided, buses must be routed to the maximum extent feasible in light of the geographic distribution of students, so as to serve students assigned. Information below shows the breakdown of students using SDIRC transportation. Also attached is the advertisement for transportation for those students choosing a "choice" school.

### **REQUIRED ACTION AS A RESULT OF THE JOINT PLAN:**

Required Action 1: School District is continuing to follow the requirements of the 1967 order with respect to transportation.

RECOMMENDATION 1: Report showing student enrollment numbers versus students riding school buses. Breakdown by school into subgroups of race for those busing to school.

Required Action:	Section VIII: Transportation The School District of Indian River County will continue to operate under the requirements of the 1967 and 1994 order. Evidence is still being provided to show compliance with order.
Explanation of Evidence:	Evidence A is a copy of the flyer for School Choice explaining transportation options. Evidence B shows the number of students using SDIRC transportation (by race and ethnicity).
Results of Action Taken:	By creating Depot Stops, the district provides those students participating in afterschool programs at each school a timelier ride home than in previous years. By listening to our families, we have also created School Choice transportation. For 2020-2021, the district offers transportation to any student that wishes to attend a "choice" school. Students previously choosing a different school than their "home" school had to provide their own transportation.
Reflection:	In previous years, transportation barriers existed for students. Many parents complained that the ride home took too long because children were being dropped off at either their regular bus stop or house. By creating the DEPOT STOPS- this has reduced the ride home time and allowed more students to participate in afterschool programming. For the 2020-2021 school year and the introduction of SCHOOL CHOICE, the district is providing transportation for any student choosing to go to a school that is not his/her "home" school. This allows for ALL students to truly choose the specific programming that they are interested in at each level- elementary, middle, and high.
