Ability to design and implement an instructional program to meet the needs of target populations. Knowledge of prescribed curriculum. Basic understanding and knowledge of current technology. Knowledge of learning styles and skill in using varied teaching methods. Knowledge of adult learning theory. Knowledge of current trends, research and best practices related to education. Ability to communicate orally and in writing. Ability to work cooperatively and collaborate with a variety of students, staff, community agencies and organizations. Skill in handling problems, concerns and emotional distress with sensitivity and tact. Ability to plan, establish priorities and implement activities for maximum effectiveness. Ability to assess levels of student achievement, analyze test results and prescribe actions for improvement. Ability to maintain appropriate student supervision so that students have a safe and orderly environment in which to learn. Ability to work effectively with peers, administrators and others.

- * (6) Maintain a positive, organized and safe learning environment.

- * (9) Use effective student behavior management techniques.
- * (10) Enforce school rules, administrative regulations and board policies.

- * (21) Apply principles of learning and effective teaching in instructional delivery.
- * (22) Use a variety of instructional strategies appropriate for teaching students from diverse backgrounds with different learning styles and special needs which enhance the application of critical, creative and evaluative thinking capabilities.
- * (23) Use appropriate material, technology and other resources to help meet learning needs of all students.
- * (24) Provide appropriate instructional modification for students with special needs, including exceptional education students and students who have limited English proficiency.
- * (25) Recognize overt indicators of student distress or abuse and take appropriate action based on school procedures and law.
- * (26) Provide instruction on safety procedures and proper handling of materials and equipment.
- * (27) Foster student responsibility, appropriate social behavior, integrity, valuing of cultural diversity and respect for self and others by role modeling and learning activities.

Collaboration

- * (28) Communicate effectively, both orally and in writing, with other professionals, students, parents and the community.
- * (29) Provide accurate and timely information to parents and students about academic and behavioral performance of students.

- *(30) Collaborate with other professionals and parents after recognizing student distress or abuse.
- *(31) Collaborate with peers and other professionals to enhance student learning.

Staff Development

- *(32) Engage in a continuing improvement of professional skills and knowledge.
- *(33) Establish and implement an individual Professional Development Plan annually in accordance with state and district requirements.
