- * (25) Use a variety of instructional strategies appropriate for teaching students from diverse backgrounds with different learning styles and special needs and which enhance the application of critical, creative and evaluative thinking capabilities.
- * (26) Use appropriate material, technology, and other resources to help meet learning needs of all students.
- * (27) Provide appropriate instructional modification for students with special needs, including exceptional education students and students who have limited English proficiency.
- * (28) Translate orally and in writing from English to Spanish and from Spanish to English.
- * (29) Recognize overt indicators of student distress or abuse and take appropriate action based on school procedures and law.
- * (30) Provide instruction on safety procedures and proper handling of materials and equipment.
- * (31) Foster student responsibility, appropriate social behavior, integrity, valuing of cultural diversity, and respect for self and others by role modeling and learning activities.
