- Teacher Optional days
- Teachers would have to work 4 out of 7 optional days to meet teacher contract, while allowing staff to participate in holidays of their choosing.
Early Release Days
- Beth Cristifalli, mentioned 32 hours of PD, need to address based on the previous conversation. May need to discuss why reduced to 178. There was no MOU written. Also discuss with SDIRC and IRCEA.
- Will lose a few students hours
