



## SRHS SAC MEETING MINUTES

- A. Meeting was called to order at 3:32 PM.

- C. Action Items
  - 1. The minutes were approved from 2/13/23 meeting. The motion was made by Kristen Reiman and seconded by James Hamilton. The vote to approve was unanimous. There was no March meeting.
  - 2. Amendment of SAC Bylaws was discussed. Two bylaws were presented to amend. Article VIII, Section 3, paragraph 2 and Article VIII, Section 4, paragraph 1 were presented to change the language to change meetings from monthly to no less than 5 meetings a year. The bylaws were reviewed and it revealed a need for a 30 day notice required to be sent to members before a vote. Notice and proposed amendments will be sent out before the next meeting.
