Principal's Report

Mr. O'Keefe reviewed the Florida School Recognition Plan (FSRP) A+ Funds

Two years ago, VBHS was a C school – Improvement from C to B to A which allows VBHS to be eligible for “more funds”

Plan : Total award from the State will be divided equally among all full-time employees for a one-time monetary bonus. Employees will include all faculty and support staff assigned to VBHS for the 2017-2018 school year that are still employed with the school district of IRC, or that retired at the end of the 2017-2018 school year. Employees assigned to VBHS less than full-time will receive a pro-rated amount of the bonus dependent on the amount of the hours they are assigned at the school.

Ashley Simmens made a motion to approve the plan, and Vicki DeGroat seconded. Johnny Taylor and Edie Collins discussed alternatives. The plan was approved by SAC Committee unanimously, and School District of Indian River to be advised of VBHS intentions.
