School District of Indian River County – 21st Century Community Learning Program Student/Parent Acknowledgement Form

The 21st Century Community Learning Center (CCLC) is a grant program offered at Pelican Island Elementary School in the School District of Indian River County. The program offers safe havens to students and families while providing opportunities for on-going learning experiences. There will be an academic program, remediation/tutoring, and enrichment activities offered Monday through Friday afterschool. The program will not occur on early release days. It is expected that each child attends every day from the first day of the program until the last day of the program for the full time daily time span. Family events will be held throughout the year. Please plan to attend as many family activities as possible with your child. Daily student attendance and family participation is vital for grant funding and non-attendance could put the program at risk for non-renewal.

Our program is set up with a staff to student ratio of 1:10 for academic subject areas and 1:15 for enrichment activities. Positive reinforcement will be used to promote appropriate behavior. If behaviors occur that prevent other students from learning, warnings, suspensions, or potential terminations from the program may occur. Harassment and bullying will not be allowed and a "zero tolerance" policy is in effect for any weapons or controlled substances. The program reserves the right to suspend or terminate immediately depending on the behavior. Please refer to the handbook for more information.
